1.1 Introduction

Each coach (bus) shall be awarded independently to the highest sealed bid. The Minimum Bid amount for each coach is three thousand dollars (\$3,000.00).

Late submittals shall be deemed nonresponsive and returned to the Bidder.

Except as otherwise provided for herein, Bids which are incomplete, or which are conditioned in any way or contain erasures, alterations or items not requested, or which are not in conformance with this request or applicable laws, rules and regulations, may be rejected as nonresponsive.

2. SEALED BID FORMAT AND CONTENTS

2.1 Bid Format

Bids shall be submitted as a PDF on the Bid Submission Form, Exhibit C, provided by STA. All text shall be in English language.

2.2 Single or Multiple Coach Bids

A single Bid Submission Form shall be used whether bidding on one (1) coach or multiple coaches.

3. BID ACCEPTANCE

Bids for each coach will be considered individually. Award will be made to the highest bid for each coach.

In the event equal bids are submitted for the same coach, determination of award will be made by flipping a coin.

3.1 Notice of Award

Winning bidders shall be notified via the email address in the contact information provided in the Bid Submission Form.

3.2 Payment

Payment shall be due within seven (7) days following notice of award. Acceptable methods of payment are identified on the Bid Submission Form.

4. SEALED BID BUS SALE AGREEMENT

STA's Sample Sealed Bid Bus Sale Agreement (Sample Agreement), Exhibit B, will be executed with the awarded Bidder(s). Bidders should review the terms and conditions of the Sample Agreement and understand that by submitting a bid, they are acknowledging that they will agree to the terms and conditions therein.

SEALED BID BUS SALE AGREEMENT

This Bus Sale Agreement (“Agreement”) is entered into by and between **XX** (“Recipient”) and the **Spokane Transit Authority** (“STA”), a Washington State municipal corporation; each individually referred to as “Party” and jointly referred to as “Parties”.

In consideration of the mutual promises herein, the Parties agree as follows:

1. STA shall provide the following “Coach” to the Recipient:

Year:	Make:	Model:	VIN:	Sale Price

2. The Recipient shall be responsible for transferring title of the Coach into the Recipient’s name within five (5) business days of receipt of Coach title from STA. The Recipient shall be responsible for all fees associated with title transfer, licensing and registration of the Coach. STA shall file a Report of Sale with the Washington State Department of Licensing following release of the Coach to the Recipient.
3. Recipient shall be responsible for removing all STA brand markings and certifies that they shall do so prior to reselling, leasing, putting into service, or regular use of the Coach.
4. STA is providing the Recipient the Coach AS IS, WHERE IS, WITH ALL FAULTS and WITHOUT RECOURSE regarding the condition of the Coach. STA makes NO EXPRESSED or IMPLIED WARRANTIES of MERCHANTABILITY; NO EXPRESS or IMPLIED WARRANTIES of FITNESS; and no EXPRESS or IMPLIED WARRANTIES or GUARANTEES of any kind regarding the Coach.
5. The Parties agree that STA shall have no liability of any sort arising from or related to the Coach. The Recipient and any successor shall defend, indemnify and hold harmless STA, its officers, directors, employees, representatives and agents from any claims or suits at law or equity, costs and/or demands of any sort, including reasonable attorneys’ fees, arising out of, or related to this Agreement, the Coach, or any use by any person of the Coach.
6. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall constitute an original Agreement, but all of which together shall constitute one and the same instrument.
7. Electronic Signatures. A digitally executed, or signed copy of this Agreement transmitted by facsimile, email or other means of electronic transmission, shall be deemed to have the same legal effect as delivery of any original executed copy of this Agreement.
